## VI. <u>ITEMS SCHEDULED FOR ACTION</u>

#### A. BUSINESS (60 minutes)

- 1. Approve a new 401(k) plan with Cuna Mutual Group that will be an ERISA Plan and allow for employer matching, determined annually, by the Board of Directors.
- 2. Approve 401(k)-employer matching for the Jan. 1 Dec.31, 2022 plan year for eligible certificated staff who participate in the 401(k) Plan.
- 3. Approve a 401(k)-employer matching for the Jan. 1 Dec.31, 2022 plan year for eligible classified staff who participate in the 401(k) Plan.
- 4. Approve longevity stipends for full-time certificated and classified staff after completing specified years of service. Stipends will be prorated for part-time staff based on their respective average FTE for the preceding service period.
- 5. Approve rate increase for substitute daily rate to \$225 and long-term substitute daily rate to \$250 effective retroactively to the start of the 2021-22 school year.
