The State of California is providing SVCS with an estimated \$93,008 in funding to provide professional learning opportunities to certificated teachers, administrators, paraprofessional educators, and certificated staff to promote educator equity, quality, and effectiveness. During this public hearing, the public is invited to provide feedback, input and recommendations. For compliance with the program provisions, the Plan, with any revisions, will be approved at a subsequent, public Special Board Meeting on or before December 30, 2021.
